INTRODUCTION

The year 2007 witnessed a series of dramatic and political events in the Occupied Palestinian Territory. Following the last PLC elections which resulted in Hamas victory, a new government was formed. However, sanctions were imposed on the Hamas led government. Essential-service delivery and Palestinian institutions were seriously undermined; salaries of 175,000 civil servants were frozen due the international aid cut-off and Israel's withholding of some \$600 million of tax revenues to the Palestinian National Authority (PNA). The Palestinian economy declined significantly; in the first half of 2007, 58 per cent of Palestinians were living below the poverty line, and 30 per cent in extreme poverty. Israel arrested a number of Palestinian ministers and the elected members of the Palestinian Legislative rendering the latter ineffective. The Saudi government brokered a Hamas Fateh agreement and a national unity government was established. However, this government was short lived following the unprecedented clashes in Gaza. An emergency government was established which later became a transition government. Gaza emerged into an emergency situation due in the economic and political siege imposed by the Israeli government. Gaza's economy had largely collapsed; access to and from the territory became tightly controlled, and as a results, its entire population of 1.5 million were livening under poverty level.

Approaching the end of the year, the Annapolis conference produced a substantive document, which was considered as an essential step for successful negotiations; leading to the end of occupation with the eventual establishment of a Palestinian state. However, it is increasingly hard to see how the desperately needed political progress in the peace process can be made on the back of the kind of human suffering we are seeing today. Palestinians in the Occupied Territory continue to experience major sufferings due to ongoing Israeli military attacks and settlement activities, in addition to the construction of the segregation wall, and extensive mobility blocks in the West-Bank.

In spite of the difficult social, economic and political situation in the West Bank/Gaza, with the rising levels of insecurity, unemployment, and poverty among Palestinians, ARIJ had intensified its activities. A variety of projects had been executed through the institute's main programs of sustainable agriculture, natural resources management, monitoring Israeli settlement activities, as well as empowering the capacity of Palestinian Authority in the fields of environment and natural resources management.

ARIJ had implemented several activities that aimed at improving food security and livelihood through contributing to sustainable income, agricultural production security, waste water and water management, developing capacities, skills, and community participation for marginalized, impoverished and vulnerable rural households.

In the program of agricultural production security, 73 different localities in Bethlehem, Hebron Tubas and Jenin were targeted; serving 2120 families of farmers. In total the year 2007 was notable by the production of 107 tons of cereals, 210 tons of green and dried forages, 3180 tons of home gardens and green houses' vegetables, 90 tons of healthy olive fruits, and 680 kg of honey. Not forgetting the creation of 17,000 cubic meters of rainwater storage capacity per year and the treatment of 13,600 cubic meters of grey water per year. In this year, the feed and shelter conditions of 3000 heads of sheep were also improved. In addition, ARIJ has created 32,300 working days for members of projects' targeted households and has provided 9110 paid working days for members of the targeted localities.

In field of waste water management, ARIJ managed to construct and run a medium scale waste water treatment plant to serve Nahaleen village with a capacity of 50 cubic meters a day. Additionally, the institute started the construction of 180 small scale waste water treatment units in Bethlehem and Hebron governorates.

ARIJ continued monitoring Israeli activities in the Palestinian territory, as more than 200 case studies and special reports were produced and published on POICA web site. The POICA web site was intensively visited during the year 2007, as the number of its hits reached around 7.5 million. Furthermore, a new web-based data base was developed and issued, to document the Israeli military orders in the Palestinian Authority.

Through utilizing its research experience and available information ARIJ had completed and disseminated the status of environment report in the Palestinian territory (SOER); to different stakeholders. ARIJ had also managed to develop the Palestinian information system for environment resources management. Moreover, ARIJ had developed agricultural and water sector review reports.

On the internal level and in order to meet the high demand by the donors and the Palestinian community on its services and development activities, ARIJ was encouraged to improve its managerial system and enlarge its staff. Consequently, the number of staff reached 72 employees compared with 62 in the year 2006, and the budget reached US \$ 2,850,000 compared with US \$ 1,880,000 respectively. Finally, the institute continued its institution development process with the completion of the two main manuals; the financial and the HR manual with their supporting software; the e-office application.

CHAPTER I: ORGANIZATIONAL STRUCTURE AND MANAGEMENT

1. General Assembly

ARIJ enjoys the services of 21 professionals who constitute the General Assembly of the institution. Their specializations vary from engineering, history, psychology, economy, science and more. They provide ARIJ administration with policy guidelines and strategic guidance. In addition, they discuss and approve the annual administrative and financial report as well as the next year budget.

2. Administrative Committee

As a part of the General Assembly commitment to effective management, values of transparency and good governance, the General Assembly elects every two years an Administrative Committee which is responsible for implementing and following up the strategies and policies set by the General Assembly.

The Administrative Committee for the year 2007 is made up of: Eng. Daoud Istanbuli (President), Mr. Fuad Rizeq (Vice President), Dr. Nasri Qumsieh (Treasurer), Dr. 'Adnan Musallam (Member), Dr. Nabeel 'Edeily (Member), Dr. Mona Matar (Member), Dr. Hassan Dwiek (Member).

4. Meetings and Decisions

During the year 2007, ARIJ administrative committee conducted 8 meetings to follow ARIJ financial and managerial issues. On the 24th of March 2007, ARIJ General Assembly had its annual meeting to discuss and approve the financial and managerial report, the financial manual, and the employment of new accounting auditor. Several donors' representatives have participated in this meeting as evidence to ARIJ institutional transparency. ARIJ has developed the Human Resource Manual and Financial Manual that were revised and accepted by the General Assembly of ARIJ and has started implementing its guidelines during the year 2007. Both guidelines have greatly participated in developing and improving ARIJ management system, and have facilitated the evaluation, documentation, follow up and editing of financial and managerial processes and have also facilitate the human resource department managerial system.

Moreover, ARIJ administrative committee made some other important decisions and actions in the year 2007; it is all part of the strategic planning of ARIJ administrative committee for future developments, investments and sustainability. It is described as follows:

* Purchasing a land from the Arab Orthodox Society-Bethlehem. The land is next to ARIJ new building.

* Increasing the number of ARIJ shares in the New Farm Company to improve broaden ARIJ horizons, increase ARIJ Inc. and to enhance the sustainability of the institute.

It is worth noting that ARIJ administrative committee is taking into account the challenging issues of US \$ dollars price reduction and the living expenses rise in the oPT, especially after the second half of the year 2007. Thus, ARIJ discussed the two issues and decided to compensate the employees by 40% of their monthly salaries which has been done by the end of the month November) and then ARIJ also compensated its employees by 50% at the end of the year 2007, as a compensation strategy to the employees' losses of the coming year 2008 due to the devaluation of the dollar. ARIJ administrative committee has also decided to study and revise the change in US\$ dollars prices and living expenses every 4 months.

CHAPTER II: PROGRAMS AND SERVICES

1. Executed Activities and Achievements

The year 2007 witnessed the implementation of quality projects that aimed at improving the food security at household level, increasing living conditions for needy families, improve resources management, water and land as well as increasing job opportunities mainly in the projects' targeted areas (see Annex 1). ARIJ has also provided intensive training, extension, and capacity building activities, in addition to innovative research activities and technology adaptation, in the field of natural resources management, environment, land use and technology.

1.1 Natural Resource Management Program

This program aims to assess alternative options, policies and strategies to conserve natural resources and promote sustainable development which can be used as the basis for formulating recommendations and informing strategic decision making to improve the management of these resources and assist in their sustainability. Additionally, this program will focus on the role of society in managing natural resources and participating in the development of national strategies, plans and in the decision making process. The program also assists in improving Palestinians' management of their natural resources, through an environmental and feasible approach, so that efficient management will be encouraged and sustainability shall be increased through the implementation of new developmental projects and innovative techniques.

1.1.1 Water & Environment Research Department

ARIJ conducted several projects and consultancies during the year 2007 in the field of water and environment. ARIJ continued implementing the activities of the project entitled "Water Harvesting and Wastewater Reuse towards Developing Water Resources and Improving Food Security in Bethlehem and Hebron Governorate" for the second year. The project, which is supported by is broken down into two complimentary action categories: Rainwater harvesting and Wastewater treatment and reuse. As regards to the water harvesting part, 20 top-roof rainwater harvesting cisterns were constructed, producing an annual of harvested water of 1,540 m³. Concerning the project's activities relevant to the wastewater management part, all of the construction works, installations, and the operation of the Waste water treatment plant (WWTP) at Nahhalin village (See photo (1)), were accomplished, in addition to the conduction of training and awareness campaigns. The treated wastewater is reused to green the mountain area located close to the WWTP site in order to develop it into a public park. The WWTP has a capacity to treat 50 cubic meters / day. The villagers will benefit from the service of wastewater collection that is taking place on a daily basis to operate the WWTP and from the prevention of the random disposal of wastewater. This project is supported by MCC and SDC.

The success of this pilot project resulted in the implantation of another project that aims at producing 180 Small Scale Waste Water Treatment Plants on household level during the coming three years to be distributed to the areas that are mostly affected by the negative environmental impacts as a result of the lack of sewage network through the MCC support. Accordingly, the project entitled "Introducing Small Scale Activated Sludge Filtration System for Wastewater Treatment in the Rural Areas of Bethlehem and Hebron Governorates in the West Bank" has started in both Battir and Nahhalin villages, through which 20 households were selected in cooperation with village councils. Additionally, 6 wastewater treatment plants were imported from Germany and 2 units are already locally constructed.

ARIJ continued implementing the activities of Bethlehem 21 project entitled: "Environmental Sustainability for a better life: An integrated Approach for Localizing Agenda 21 in the Bethlehem District" for the second year. The project, which is funded by the EU-Life program is using a participatory approach in the form of a visioning process that focuses on bringing together a broad section of the community with the local authority to develop a shared vision for the sustainability of their community and plan how to achieve it.

An effective participatory process was established including the public awareness campaigns (See Photo (2)) and the baseline community profiles were created including the reinforcement of the capacities of 10 employees from the involved local councils on GIS techniques and database management and the transfer of the established GIS based information systems and the computers to the targeted local councils during the closing meeting of the training that was organized at ARIJ premises (See Photo (3)). Currently, ARIJ is creating community profiles and disseminating the assessment of the project findings.



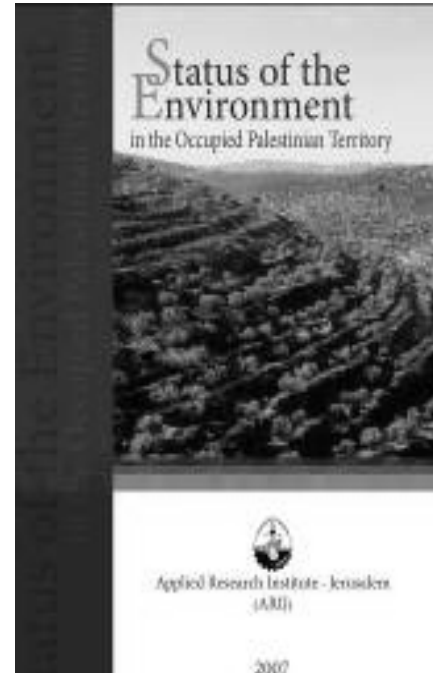

Bethlehem 21 project is in accordance with the sixth Environment Action Programme (EAP) of the European Community, which calls for a broad involvement of stakeholders in every stage of the policy process from agreeing targets to putting measures into practice. It is in line with the 6EAP in that it creates sound scientific knowledge and economic assessments, reliable and up-to-date environmental data and information and the use of indicators to underpin the drawing-up, implementation and evaluation of environmental policy. The project also responds to Aarhus Convention, through the applied participatory approach that engages community members in the decision making process that will lead to the development of local sustainability action strategies. Moreover, the project will empower the citizens in defining their future goals and design the plans and actions towards achieving these goals.

During this year, ARIJ also continued its activities of the project entitled "Update of the Palestinian Environmental Information System", which is supported by SDC. Spatial and attribute data on land, water, environment, Israeli colonizing activities, socio-economic conditions and infrastructure were collected from the available databases, maps, publications, analysis of satellite images, field data, and from national authorities. All the available and collected data were harmonized and integrated into a desktop-based-interactive GIS application "Palestinian Environmental information system -PIES". The knowledge accumulated from data collection and analysis were synthesized and all relevant national laws, policies and strategies that have an impact on the environment were reviewed to develop the Status of the Environment in the Occupied Palestinian Territory (SOER) 2007 report. In order to disseminate the project results and findings to decision makers and the lay public, the prepared SOER report was published in the form of a soft cover book and posted on ARIJ website in order to make it accessible to a wide group of people. It is worth mentioning that two workshop were organized, one targeted all the Palestinian stakeholders and the second targeted the International Agencies in the oPT, to present and discuss the first draft of the Profile. The two workshops were fruitful and revealed the comments and remarks of the participants, which had been taken into consideration in the final Profile.



ARIJ was approached by UNEP to develop an Environmental Information System for Gaza. Accordingly, A GIS Training Course program was prepared by ARIJ team and conducted at the ARIJ computer lab in Bethlehem. Seven days intensive GIS training course were organized in the end of February 2007, where four staff members of the Environment Quality Authority (EQA), one staff from the Ministry of Agriculture (MOA), 2 staff from the Ministry of Transport (MOT), and one staff from Ministry of Local Government (MLOG), were trained by ARIJ to improve their capabilities in Environment research (See Photo (4)). Moreover, the established GIS Based information system for Gaza and 3 computers were transferred to the EQA during the closing meeting of the training that was organized at ARIJ premises.

ARIJ has also continued its activities in the fields of natural resources management including the analysis of water resources, monitoring air quality, development of waste management policies, through conducting field surveys, and linking dynamic models with geographical information systems. In respect, ARIJ is working on mapping the main areas of vulnerability in relation to the current deteriorating conditions of water supply and sanitation services in the West Bank and Gaza.

Furthermore, ARIJ conducted a full and comprehensive review of water sector in the West bank and Gaza. The study provides a comprehensive assessment of the current conditions, policies and investments for the development of infrastructures and service. The Water sector review report was updated and it was posted at ARIJ website.

ARIJ continued its experiences with home composting and small scale wastewater treatment plants (See *Photo (5)*). In the last 2 years, engineers of ARIJ have constructed two small wastewater treatment plant, based on the, up flow sludge blanket filtration system. Actually its effluent quality is being monitored and evaluated periodically, as an evaluation measurement. According to the Palestinian Standards the quality of treated wastewater of the locally made small scale wastewater treatment plant is acceptable for irrigation purposes (See *Photo (6)*).

ARIJ continued to develop its capacities in the field of water management keeping up with the latest technologies. ARIJ is utilizing GIS Software for groundwater modelling System, which provides tools for every phase of a groundwater simulation and WEAP software for integrated water resources planning assessments and policy analysis in order to provide a system for maintaining water demand and supply information in the Occupied Palestinian Territory.

1.1.2 Geo-Informatics Department

ARIJ continued its working relations with the Palestinian Authority (e.g. Ministry of Planning, PCBS (Palestinian Central Bureau of Statistics) and NAD (Negotiation Affairs Department), through exchanging data concerning Israeli colonizing activities that include confiscation and razing of Palestinian land, the illegal Israeli settlements building or expanding, the construction of designated

Israeli bypass roads on stolen Palestinian lands, the demolishing of Palestinian houses, and now the encroachment of the Israeli Segregation Wall on the OPT lands.

Furthermore, ARIJ started developing village profiles for Hebron Governorate for a project entitled: "Village Profiles and Azahar Needs Assessment in Hebron Governorate", funded by the Spanish Cooperation / Azahar Program. The project aims to develop an integrated planning tool and information system on the community level. The profile contains socioeconomic data; infrastructure, public services, land use/ land cover analysis, geopolitical status and maps for land use/land cover and the locations of main services and historical sites. Up to thirteen village profiles were completed.

Within the ambit of an international program for research on the interactions between population, development, and the environment, which is coordinated by the French Committee for International Cooperation in National Research in Demography (CICRED), a one-day workshop was held for the decision-makers of three municipalities, namely Bethlehem, Beit Jala and Beit Sahour (representing the urban area of Bethlehem Governorate). This workshop was convened to discuss the results produced by the socio-economics analysis, highlight the depicted main problems faced by the municipalities, underline the assessment made to the Palestinian laws and legislations and present the formulated policies and strategies of the project team.

Another workshop was held for 21 persons of the public and civil society organizations in the Bethlehem Governorate to stimulate the citizens' involvement and participation in issues regarding sustainable development. The comments concerning the suggested policies that were made at the two workshops, as well as the policies suggested by the participants of the workshops were integrated into a final revised report, which took both these comments and the evaluation of the scientific committee of the PRIPODE into consideration. Now, within the dissemination phase of the project, the project team is preparing to issue one-thousand copies of a book that summarizes all the outputs of the research pilot project (Annex 2 and 3).

It is worth mentioning that a spatial GIS-based model was developed to assess the potential suitability of locations for urban growth in the Bethlehem Governorate. The analysis aims to aid the decision makers at both local and regional levels to avoid any negative side effects of unplanned development through the consideration of two distinct scenarios dealing with past, current or future Political and Environmental constraints.

The Geo-Informatics Department is continuing to act as a service provider, in which it constantly supports the other projects at ARIJ with statistical data, maps and geographic records needed for their research and projects. The GIS at ARIJ is involved in variety of applications, these applications as diverse as natural resource sciences, urban development and analysis, automated mapping and facility management (AM/FM) systems, land information systems (LIS), agriculture and geopolitics.

Most recently, ARIJ introduced and used the GIS as a decision support system to enhance the performance of the municipalities and local government by conducting on job training for 8 municipalities and local councils in Bethlehem governorate for a period of 6 months.

Moreover, the GIS and RS at ARIJ have supported many other national organizations with related reports, data and maps. The unit has also worked with the local communities to build their capacities and skills and to enhance their knowledge in GIS. ARIJ continued its contribution to the training of the "new generation" of Palestinian and Arab specialists in the area of GIS, remote sensing and their applications in natural resource management.

Major ARIJ GIS Activities during 2007 included:

- Analyzing the Land use Land Cover (LULC) for the West Bank Area extracted from high resolution Aerial Photo 2004 pixels size 1 meter (January 07).
- Analyzing the Land use Land Cover (LULC) for the West Bank Area extracted from high resolution Aerial Photo 2006 (May 07).
- Preparing the first draft of the Atlas of 40 years of Israeli Occupation.
- Launching the Interactive map using the Google Earth Env.
- Printing Geo Political posters for West Bank and Gaza.

- Conducting a workshop about land information systems (LIS)
- Preparing the “Tourist Maps for Bethlehem and Area and Ramallah City”.

1. 1.3 Urbanization Monitoring Department

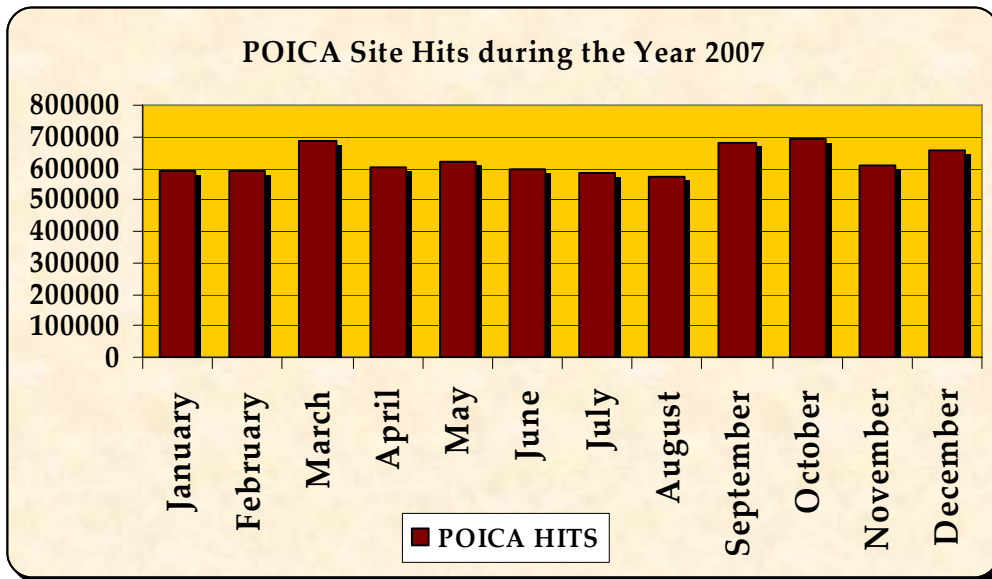


Figure 2: POICA hits

During the year 2007, the Urbanization Monitoring Department prepared and published on POICA website (the joint website between ARIJ and LRC), a total number of 213 case studies, 12 monthly reports, and 13 special reports covering the Israeli activities in the occupied Palestinian Territory, and published 31 newspaper articles. Furthermore, the research staff conducted several visual (5) and audio interviews (12) dialogues (see annex 4, 5). POICA’s website had some 7,498,692 hits during the months of January till December (2007) with an average daily hits exceeding 20,500 (See Figure 2). Moreover, during 2007, the department gave many presentations to local, regional and international groups. (See Annexe 4)

The department’s members attended several workshops and conferences during the designated period of the report, all of which tackled issues related to illegal Israeli settlements activities in the context of international law and international humanitarian laws (Annex 2). It has disseminated information in hardcopy form and through presentations delivered to audience tackling the Palestinian – Israeli conflict both locally and internationally (Annex 4).

The department prepared case studies to report illegal Israeli colonization activities (building and expanding settlements, land confiscation, house demolition, uprooting trees, etc and the Segregation Wall) in the occupied Palestinian Territory and its various impacts on the different aspects of the Palestinian communities; the environment, health, education, freedom of movement, freedom of religion, human rights, etc and on the peace process. The year 2007 has witnessed a new marking in the number of case studies published of the past 10 years of the project’s life. Figure three shows numbers of case studies published since 1997 to 2007.

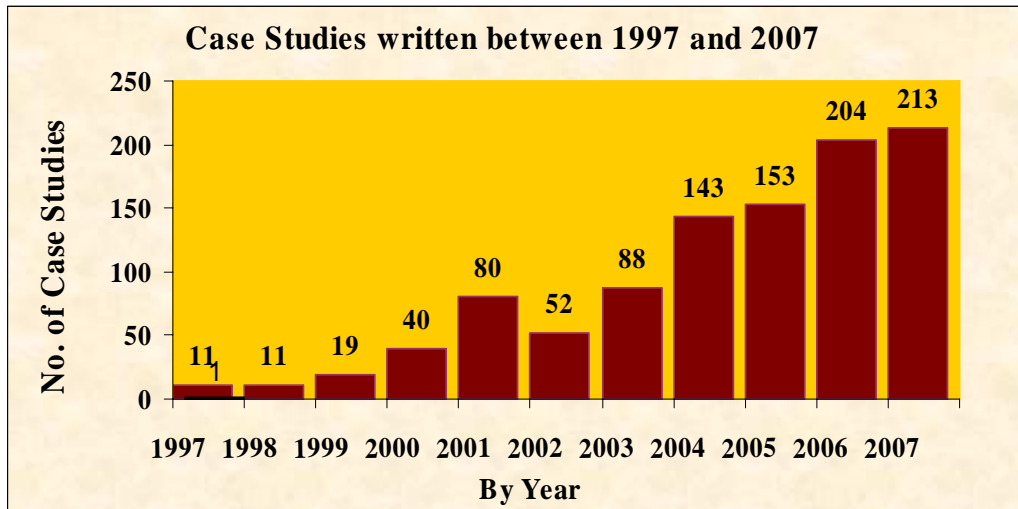


Figure 3: Case studies written between 1997 and 2007

Fieldwork constitutes a significant aspect and a core activity of work of the department. The research staff organized frequent visits to villages and communities affected by the Israeli violations to assess the extent of the changes on the ground, investigate the Israeli activities in the affected areas, and appraise the impact on the local Palestinian communities. To this end, teams from the Monitoring unit visited 114 locations in the West Bank. During their visits, the teams photo recorded changes, and obtained information from local government officials, and people affected regarding Israeli activities; after which, the generated information are translated into case studies. At many occasion, field workers needed to revert to the location of the events either to obtain more information and photos, to conduct interviews and/ or capture the Israeli Army in action.

1.2 Sustainable Agriculture Program

This program focuses on promoting sustainable agriculture to increase the profitability of agricultural production and food security in the Palestinian Territory. Additionally, the program activities shall focus on improving the livelihood of vulnerable and marginalized societies in the Palestinian Territory through improving their accessibility to land, water, food and biodiversity resources.

The capacity building of targeted areas and agricultural sectors (formal and informal) are being targeted to maximize the benefit and optimize the management of natural resources to improve food security and mitigate poverty. Additionally, this program aims to assist decision makers and stakeholders in developing agricultural plans and strategies and improve the availability of reliable information and data as an effective management tool.

The forestry project, which is funded by the Ministry of education and higher education become at the final stage and during the coming six months the report and the related database will by published and some of the MoA forests specialists will be trained on the project findings and how to use the developed forestry database. This project has surveyed the biotic and abiotic conditions of two main forests in Hebron Governorate and considered as a pilot project for future surveys for forests in West Bank Photo (7).

Furthermore, ARIJ's Sustainable agriculture program has continued its Agro-developmental activities to preserve and improve the local seeds, including the continuation of the research program that is done on local seeds improvement for rainfed field crops and cucurbits, and to assist in improve the vulnerable rural households' food security in the Palestinian Territory.

Through ARIJ unique relationships either with local institutions such as ESDC Economic and Social Development Centre, and international institutions such as the Canadian Food Grains Bank (CFGB) and the Mennonite Central Committee (MCC), the EU food security program, CARE international, the Spanish Cooperation and International Agency for International Aid, ACDI/VOCA with USAID fund, and Austrian aid; ARIJ and its partners were able to successfully target 2120 households distributed over 73 Palestinian urban localities mainly from Hebron, Bethlehem, Tubas, and Jenin governorates, forming up to 4% of the total households in the targeted localities. This was accomplished through the cultivation of 2560 dunums with locally produced seeds of field crops and forages, and the cultivation of 100 dunums with fruit trees seedlings. The main purpose of these activities is to enhance the sustainability of the rainfed farming system by increasing the planted areas and production; to improve household food security, and to assist in improving self-sufficiency of the strategic and cash crops in Palestine (see Photo 8).

On the other hand, 1530 dunums of olive trees fields were provided with olive fly traps to improve the quality and the quantity of the produced olive oil.

This is in addition to the rehabilitation and cultivation of 220 dunums of home gardens including the drip irrigated networks, the cultivation of 269 small green houses over a total area of 26 dunums, and 132 dunums of green houses were rehabilitated for intensive cash crop cultivations.

This year ARIJ has restored 105 home cisterns and has constructed 140 new cisterns with 70 cubic meters each for rainwater collection. 50 grey-water treatment plants were established to be used for irrigation purposes. The Agricultural Artas channel was also rehabilitate through the utilization of 700 m of new galvanized pipes so as to develop and improve the water management system and thus to increase Artas cultivated areas by 35%.

Furthermore, ARIJ and its partners have succeeded in distributing 114 beekeeping cells and 134 heads of pregnant sheep including the establishment of 70 small ruminant shelters for feed and shelter improvement.

One of the distinguished performed activities in the year 2007 was the fare for rural products of the ARIJ targeted projects' households and cooperatives. The fare was conducted between 7th and 10th

of June 2007 in the Peace Centre in Bethlehem city to give the opportunity of the southern people and consumers to see, taste, and purchase the northern parts rural products.

In total the year 2007 was notable by the production of 107 tons of cereals, 210 tons of green and dried forages, 3180 tons of home gardens and green houses' vegetables, 90 tons of healthy olive fruits, and 680 kg of honey. Not forgetting the creation of 17,000 cubic meters of rainwater storage capacity per year and the treatment of 13,600 cubic meters of grey water per year. In this year, the feed and shelter conditions of 3000 heads of sheep were also improved.

In addition, ARIJ has created 32,300 working days for members of projects' targeted households and has provided 9110 paid working days for members of the targeted localities. Up to 57 training days were conducted for Palestinian farmers and 1250 technical and extension visits were conducted by projects' specialized teams.

1.3 Information and Technology Program

This program aims to improve ARIJ's capabilities in computing technology and applications, such as networking, hardware and software development, management, the internet and computing systems security. In addition to keeping up with the latest remote sensing and geographical information system software that follow an object oriented approach towards image analysis.

In 2007, ARIJ has continued improving its capabilities through benefiting from its existing and recently employed staff expertise in IT and computer. From this, more IT services and products to serve ARIJ current projects and conducted consultancies were introduced. The IT program provided assistance to all ARIJ staff during the period of January 2007 till December 2007, through installing software applications, maintaining hardware, and maintaining and updating the local area network. Currently one of the major tasks that the IT program is conducting is the virtual and interactive development for the different projects at ARIJ. IT program members work closely with the GIS & Remote Sensing staff for developing GIS stand-alone and web applications.

ARIJ has extended its activities towards developing an office automation system as an internal monitoring and evaluation system that is currently in the final phase of development.

Throughout the year 2007 Information Technology program at ARIJ was responsible for the following activities.

1. The completion of constructing the Palestinian Environmental Information System (PEIS) application in which IT employees were responsible for developing a stand-alone GIS based application combined with the environmental databases that were constructed in cooperation with all ARIJ Units and the Palestinian Central Bureau of Statistics (PCBS).
2. Integrating ARIJ GIS layers with Google Map and publishing the project on ARIJ site.
3. Starting on the development of ARIJ Electronic Office application (E-Office) that will include the following parts:
 - a. Human Resource (Payroll, Timesheet, ARIJ internal Forms processing ...etc)
 - b. Project Management (Activities, Donors ...etc)
 - c. Finance (Requisition forms , Tenders & Quotations ...etc)
 - d. Administration

This project is a combined effort from both IT unit and the administration unit.

4. Network Administration and maintenance.
5. Start integrating Map-server open source application to ARIJ geospatial database, and the development of a web based mapping solution that will operate instead of ESRI ArcIMS.
6. A consultancy for a German based driving school in which IT unit developed an online written driving exam system that will be used by students to study and train for the official exam.
7. The construction of different web sites for ARIJ projects.
8. Continue the construction of a web application for ARIJ library. The system can be accessed by all employees to search the library and borrow books.
9. The development of the "Israeli Violations" web application part of the monitoring of the Israeli colonization activities in the Occupied Palestinian territories Project. The system is being used to monitor and electronically archive and report violations in the West Bank and Gaza since 1996 till now.
10. The designing and development of the Palestinian Development electronic forum which is hosted at ARIJ (<http://forum.arij.org>).
11. Training Jericho Joint Council Services Planning and Development (JCSPD) on using the portal system that was developed by IT staff for their site.
12. The updating of the Palestinian System for Environmental Resource Management (PSERM) that was first developed in the year 1997.
13. The participation in the 2nd METIS Training & Seminar in Cairo. METIS (MEdiTerranean Introduction of GNSS Services) is a project, launched in the framework of the Euro-MED GNSS I Programme, to pave the way for GNSS services in the Mediterranean region. Launched by the Galileo Joint Undertaking (GJU) in July 2006. The main objective of this project is to facilitate the introduction of GNSS services in the MEDA area. ARIJ is a partner in the project and will be installing GNSS receiver in the year 2008.

In 2007, ARIJ continued to develop its capacities in the field of GIS and RS keeping track with the latest technologies, which include upgrading available software: ArcGIS 9.2, PCI software, ArcIMS, and obtaining Ecognition software that follow an object oriented approach towards image analysis. Ecognition also provides a whole bundle of innovative features and techniques for automated image analysis, with the multitude of additional information that can be extracted from image data after segmenting it into image objects and through handling even textured or low contrast data, such as very high resolution (VHR), airborne, or radar data.

2. SERVICES AND CONSULTANCIES

1. An observatory study for enhancing Palestinian agricultural marketing system in Tubas Governorate for Against Hunger-Spain (ACF), entitled: "An observatory study for enhancing Palestinian agricultural marketing system in Tubas Governorate". The consultancy aims to assist in improving the production calendar and production quality to meet marketing standards and increasing the marketing value for the Palestinian agro-production with special focus on Tubas Governorate and its agricultural marketing system. Several workshops were conducted to improve the farmers and traders performance to meet the Israeli as well as the European marketing standards to increase their profit and sustain their activities.

2. Development of Environmental Information System for Gaza for the UNEP
3. Review for the Palestinian Agricultural Sector for the Spanish Cooperation. The Agricultural Sector Review report was updated and it was printed by the end of the year 2007. This report discusses all the agricultural sector components with proposed developmental scenarios.

CHAPTER II: NETWORKING & DISSEMINATION OF INFORMATION

1. Networking

1.1 Cooperation with the Palestinian Government, NGOs and Institutions

▪ **Ministry of Agriculture (MoA)**

Since the beginning of the year 2007, ARIJ has focused on empowering and strengthening its relation and partnership with all agricultural stakeholders. In March 2007, the MoA Ministry Deputy (Dr. Azzam Tubailieh) with eight General Directors and the Director of Bethlehem Governorate have visited ARIJ. The issues of strengthening MoA's relation with ARIJ, and the current status of the Palestinian agricultural sector were discussed. Additionally, ARIJ has participated in reviewing the MoA's action plan for the years 2007-2008. The coordination with MOA continued on different levels through conducting joint meetings to discuss the agricultural status in the Palestinian Territories and future strategies to improve the status of the agricultural sector. These meetings took place at ARIJ, the ministry and agricultural sector working groups. On the technical level, ARIJ is coordinating with MOA's directorate in Bethlehem governorate the workshop that is going to be conducted about governorate's agricultural organizations, possible ways of improving the relationship and cooperation among the different organizations and the mechanism for avoiding the duplication. In addition, ARIJ is coordinating the development of a joint database for the current projects and beneficiaries as well as discussing the future plans and needs. On the other hand, ARIJ involves the MOA extension agents in all its agricultural projects mainly in the field extension visits and while selecting suitable beneficiaries for each project. MOA is always member of the community committees that are formulated by ARIJ when starting implementing its agricultural projects, which help ARIJ proceeding in its project conduction especially while selecting the project beneficiaries.

▪ **Palestinian Water Authority (PWA)**

ARIJ continued its organic relationship with the PWA, exchanging data and information with the Ministry in addition to its participation in all Ministry-conducted workshops, meetings and brainstorming sessions. Furthermore, ARIJ has executed a consultancy to review the Palestinian water sector for the Austrian Development Agency (ADC). This resulted in producing the Water Sector Review Report. This report will be published during the year 2008

▪ **Ministry of Planning**

ARIJ continued its working relations with the Ministry of Planning, as they exchange exchanging data and information concerning Israeli colonizing activities in the oPT.

▪ **Bethlehem Governorate**

ARIJ has continued to be a member of the Bethlehem governorate advisory committee. ARIJ continued to provide the governorate with available information about land use/land cover and further continued working with the ministry to find new sources of funding for the land registry project. On the level of other governorates, ARIJ continued to provide them with maps; information and data about land use/land cover analysis, environmental information and updates on Israeli settlement activities.

▪ **Municipalities and local councils**

ARIJ has continued reinforcing and strengthening the relationship with the Palestinian Municipalities and local councils and is still working on developing the local governmental bodies through adopting Agenda 21 and building their capacities in GIS and land use management. In addition to this, ARIJ is still working jointly with the governmental bodies to develop the management capacities in waste such as the current project for establishing waste water treatment plant in Nahhalin village. Services to the local community, municipalities and village council's were provided nearly on daily bases through out the year on different issues but mainly helping and supporting them with analyzed maps and aerial photos in order to follow up a law suite in Israeli courts concerning confiscated lands and the wall issues. Services of ARIJ were not limited to municipalities, village council's only, ARIJ supported nearly all divisions of security forces in Bethlehem area, their main headquarters in

Ramallah and even the president office with professional maps for the West bank and Gaza, besides supporting them with information, fact sheets, presentations, latest research results and publications.

▪ **Palestinian Central Bureau of Statistics (PCBS)**

ARIJ continued working relations with PCBS through exchanging data and information concerning Israeli colonizing activities in the oPT. Also, ARIJ participated in the training done by PCBS on SPSS software and applications for demography.

▪ **(Negotiation Affairs Department (NAD))**

ARIJ continued its working relations with NAD through exchange data concerning Israeli colonizing activities in the oPT.

▪ **National Coalition for the Global Call for Action against Poverty-Palestine (NCGCAP)**

ARIJ continues being a member of the steering committee of NCGCAP and. ARIJ also participated in the dissemination of information concerning Palestinian awareness regarding poverty in the Palestinian Territories.

▪ **Palestine Economic Policy Research Institute (MAS)**

ARIJ became a member of the food security monitoring committee, which recently was established by MAS.

▪ **Economic and Social Development Center of Palestine (ESDC)**

ARIJ has continued its cooperation with ESDC through the LIOPT project implementation, institutional development and management system. Other several joint project proposals were submitted for potential funding.

▪ **Palestinian Non-governmental Organization Network (PENGO)**

ARIJ is involved actively in all PNGO network activities, which includes besides the weekly steering committee meetings, ARIJ Became head of certain committees to follow up issues such as the agricultural sector working group, UN land registry, poverty and the European neighbourhood policy. After our election in the steering committee ARIJ were responsible of submitting position papers related to Development, Water & Environment, Settlements, political and negotiations, even more as leaders of the civil society in the West Bank and Gaza, ARIJ participated in various meetings for the Palestinian factions and the civil society after the hard deterioration of the situation in Gaza. On the other hand, the steering committee of PINO acts closely with the new ministers in issues related to the civil society and matters that concerns the political, economical and development in Palestine.

▪ **Agro-Eco Company**

ARIJ created contacts with Agro-Eco Company in order to develop concept proposal to be submitted to the Holland government aiming to develop a Palestinian agricultural rural production and enhance its capacities for exportation through improving the performance of the existing agricultural cooperatives.

▪ **Palestinian Association for the Development of Internet2 (Padi2)**

Since ARIJ is one of the cofounders of the association and member of both the technical and administration committee, ARIJ has continued its participation in the activities regarding PADI2. The conducted activities focused on selecting the suitable contractor for Internet connection, developing the administration policy for the users and internet speed and taking part of the negotiation with Paltel to provide inner-connection between the partner institutions.

▪ **Agricultural Rural Development Initiative (ARDI)**

The established union "Palestinian Rural Development Initiative" was formulated and ARIJ as the secretariat has prepared all necessary documents and submitted to Ministry of Interior to register the union to start its official activities. ARIJ and its partners have continued their efforts to register the formulated "Palestinian Agricultural Rural Development Union" (ARDI-Palestine). On regional level ARIJ has continued its contacts with Mediterranean Eco-Operation to find sources of fund, to activate the regional ARDI coalition and to start implementing some activities to benefit Palestinian rural people. Both parties are planning to conduct a regional conference during the year 2008 to develop the mechanism of regional cooperation and rural development strategies and action plans.

- **Land Research Center (LRC)**

The organizational partnership between LRC and ARIJ continued and improved, especially in monitoring Israeli Settlement activities and natural resources.

- **Arab American University of Jenin (AAUJ)**

ARIJ has continued monitoring and maintaining the donated air quality unit, which was established at Jenin University under the activities of a regional project that focus on monitoring air quality.

1.2. Connections with Regional and International Institutions, Bodies and NGOs

ARIJ continued its cooperation with the civil society institutions on local, regional and international levels through conducting joint research activities, participating in the conducted workshops and other related activities in agriculture, environment, natural resources management, etc. Following are some of ARIJ's carried activities and cooperation with the civil society organizations:

- **Master in International Cooperation and Development (MICAD)**

ARIJ is member the steering committee of MICAD program jointly with other Palestinian NGO's, University of Bethlehem and University of Pavia, Italy.

- **United Nation Environment Program (UNEP)**

ARIJ has continued providing UNEP with required services and information in the field of environment, natural resources and Palestinian Authority capacity building.

- **Consolidated Appeal Program (CAP)**

ARIJ is a member of Consolidated Appeal Program (CAP), which is led by FAO and OCHA. ARIJ has participated in developing the Need Analysis Framework (NAF) for the agricultural sector for the first half of the year 2007. Additionally, ARIJ has submitted two emergency projects in agriculture and food security; one of them will be included in CAP 2007 and the second one in CAP 2008. Additionally, ARIJ became a member of CAP in water and sanitation sub-sector through which two projects proposals for wastewater management were submitted by ARIJ.

- **Action Against Hunger- Spain (ACF)**

ARIJ has continued studying the marketing system in Tubas area.

- **European Geostationary Navigation Overlay Service (EGNOS)**

ARIJ has continued to be a member of the MEDaCoN (Mediterranean EGNOS Data Collection Network).

- **ACDI/VOCA**

This year witnessed a special relationship with ACDI/VOCA, where a joint project proposal was submitted to the USAID fund. ARIJ has also continued the current activities on improving food security in the West Bank, especially in the Bethlehem and Hebron Governorates.

- **CARE international**

ARIJ has improved its partnership with CARE international through signing a strategic partnership. Based on this agreement ARIJ became a permanent partner to CARE International in ARIJ's fields of joint specialty.

- **Spanish Cooperation**

The Spanish Cooperation has continued their support to ARIJ emergency program for rural areas and has continued the joint work on agricultural sector review. Additionally, the SC nominated ARIJ to benefit from AZAHAR program to conduct village profile study for Hebron Governorate. Moreover, ARIJ has transferred APIS (Agricultural Project Information System), which is funded by the Spanish Cooperation, to FAO (Food and Agriculture Organization) to takeover and updating it. Therefore, APIS become under new electronic address which is <http://www.apis.ps>

- **Swiss Agency for Development and Cooperation (SDC)**

Through the core fund project, the SDC provides ARIJ with financial contribution in implementing virtual projects, those that need contribution from applicants such as monitoring Israeli settlements activities, implementation of waste water treatment units and dissemination of information to improve

awareness of people regarding geopolitical environmental and natural resources management issues. Furthermore, the SDC has extended its support to ARIJ through funding the Status of Environment in the West Bank report and database through which all updates, changes, challenges, and developmental scenarios were developed and discussed to become as awareness and decision support system for the Palestinian stakeholders and planners.

- **The Australian Agency for International Development (AusAID)**

The AusAid are planning to issue a call for proposals for the Mediterranean Region and based on the current good relation between AusAid and ARIJ and its partners in the current LIOPT project, the AusAid is encouraging the partners to submit for LIOPT 2.

- **E-wash Committee**

ARIJ has continued participating in the e-wash monthly meetings sharing the available information and experiences with others regarding the water and sanitation matters with the aim of improving the available data and development projects.

- **Mennonite Central Committee (MCC)**

The MCC continued their support of ARIJ programs, especially in the fields of the dry land farming development program, water management and waste water treatment activities on the community, as well as in the field of vulnerable and poor Palestinian Communities.

- **Canadian Food Grain Bank**

Bank experts visited ARIJ and discussed the possibility for future coordination and support for field crops and forages developmental programs in dry areas of the Palestinian Territories and they are planning to continue their support for additional activities. Currently, the Canadian Bank is funding the ARIJ dry land farming program in partnership with the MCC.

- **Food and Agriculture Organization FAO/ World Food Program**

FAO and World Food Program are working with ARIJ on CAP (**Consolidated Appeal Program**) and NAF (**Need Analysis Framework**), where ARIJ became a member for food security, water and sanitation, and agriculture issues. ARIJ is going to submit several proposals to CAP project 2008.

- **Bioclean Co.**

ARIJ has continued its contacts with Bioclean and is willing to order some units for waste water treatment to test the units' performance and suitability for Palestinian conditions.

- **Arab Science and Technology Foundation (ASTF)**

The relationship with ASTF has improved. Both ARIJ and ASTF are working to conduct a regional conference for research strategies in the Arab countries and proposed to be in Palestine.

- **International Center for Agricultural Research in Dry Areas (ICARDA)**

Coordination and contacts continued between the organizations especially with ICARDA office in Jordan through which a concept paper for potential joint activities will be developed to empower the relationship and apply some joint activities on the ground.

- **United Nations Economic and Social Commission for Western Asia (Un-ESCWA)**

ARIJ has participated in the Workshop on National Launching of the Regional Campaign on Secure Tenure and Good Urban Governance – the Jordanian Initiative.

- **Arab Town Organization (ATO)**

ARIJ has Participated in the expert group meetings on Urban Governance and the Millennium Development Goals: towards the implementation of target 11 "Equitable Cities".

- **Habitat International Coalition (HIC)**

ARIJ has get the primary acceptance for a financial support for a joint pilot project for land registration damages incurred due to the construction of the Segregation Wall.

- **United Nations Human Settlements Program (Un-Habitat) – Global Urban Observatories**

ARIJ has developed a partnership aiming at building an Urban Observatory in the Bethlehem area.

1.2. DISSEMINATION OF INFORMATION

1.2.1. ARIJ in the Media

During the year 2007, significant growth in the number of visitors to ARIJ website was noticed through which the number of hits reaching 2, 92 millions. Additionally, up to 5, 64 millions hits were recorded for the POICA (Monitoring Israeli Colonizing Activities in the Palestinian Territories) website (POICA's web address is <http://www.poica.org>) between January 07 and December 07.

To meet the high demand on ARIJ data and publications, it was decided to increase the capacity of ARIJ main server to 1.2 terabyte. This will accelerate the internal network and assist in compiling more of ARIJ publications and data on its website to become available to the users everywhere and anytime.

ARIJ has continued its work on increase the local communities' awareness regarding several issues such as the environmental issues, natural resource management, geopolitical conditions and Israeli colonizing activities. Towards this goal, ARIJ's staff participated in a number of international and local TV programs and presented the maps and data. Several presentations were made throughout the twelve months for different international groups and decision makers and many articles, case studies, and reports were published in the newspapers.

ARIJ has published several reports in different local newspapers, such as Al-Quds, Al-Ayyam, Jordanian Al Dostoor, WAFA & MAAN news agencies local and International TV's such as Al – Jazeera, , BBC.....etc. (both in Arabic and English) the main publications for ARIJ related to water, environment, land use, settlements expansions, confiscation orders and most importantly the continuous changes in the wall. In addition, ARIJ has published several extension booklets especially in the field of agriculture and food processing. On the other hand, ARIJ has also been concerned of the water & environment issues informing the local community, ministries and the leadership of the latest threats and provocations from the Israeli side related to this issue. On the other hand, ARIJ has kept the interested people in ARIJ activities informed about its conducted activities (workshops, meeting and visitors), latest publications and technical reports in the different field of environment, natural resources managements and the impact of Israeli settlement activities including the separation wall, in addition to national and international events.

1.2.2. Conferences and Workshops

ARIJ team participated in different conducted workshops and conferences related to its field of work such as water, agriculture, biodiversity, land use, monitoring Israeli settlement activities and planning. ARIJ has participated in 101 different workshops and conferences conducted abroad (10%) and locally (90%) (Annex 2).

1.2.3. Meetings and Visits

The year 2007 witnessed many activities performed by ARIJ including visits of different delegations and key persons. The total number of performed visits and meetings reached 208 of which 34% represents foreign and international organizations, 56% from local Palestinian bodies and 10% from Arab countries (Annex 3).

1.2.4. Presentations

As part of its publicity campaign in improving the awareness of local, regional and international parties, ARIJ organized several presentations highlighting the geopolitical situation, its impact on the Palestinian natural resources and its sustainability to different key visitors and delegations at ARIJ premises and/or other places. Consequently, up to 68 presentations were given by ARIJ including updates in different aspects of which 62% were for foreigners, 3% for the Arab countries and 35% for local Palestinian bodies (Annex 4).

1.2.5. Web Visits

ARIJ website noticed a significant increase in the overall number of visitors during the year 2007. The number of hits of ARIJ website reached 8,551,845, with daily average hits of 18-28 thousands. The total

number of recorded hits significantly increased in year 2007 compared with the year 2006 by 2,413,526 visits (8,551,845 - 6,138,319).

CHAPTER III: INSTITUTIONAL DEVELOPMENT OF 2007

1. Human Resources Capacity and Development

During this year, ARIJ witnessed a number of staff changes. ARIJ continues to focus on the development of its human resources as an essential ingredient for institutional development. The high demand for ARIJ activities and the approved projects by donors and the high turnover in its staff causes interruptions in the smooth running of its research operation. This calls the attention of ARIJ's input of trained professionals in the Palestinian institutions which is firstly, a recognition of ARIJ capabilities and secondly, a recognition of ARIJ's contribution to the process of Palestinian institutional capacity building. Therefore, ARIJ has worked on attracting new employees for the purpose of growth, sustainability and development.

The total number of employees during the year 2007 ranges between 62 and 72 employees. In an effort to combat the high turnover of employees, the board of trustees decided to provide incentives for rewarding the staff who excel in their performance.

It is worth emphasizing that ARIJ staff is expert in different fields of natural resources, land use, agriculture, biodiversity, environment, administration and finance, IT and management and planning. They have diverse and varying levels of education, ranging from Diplomas, Bachelor Degrees, Masters Degrees, PhDs and Post PhDs.

ARIJ continue developing its human resources capacities through offering and/or encouraging staff to apply for scholarships to enhance their skills and knowledge in order to maximize their abilities and their role in the Institution. ARIJ also believes in the international exchange of culture and knowledge and has, therefore, developed an internal system to host the international interns and volunteers as well as developing the volunteer/intern manual to manage and follow their residency, financing system, security and satisfaction. The selection is based on the received qualifications of applicants and the need of ARIJ for their experiences. This year, ARIJ hosted 5 volunteers of whom 3 are females and 9 interns of whom 5 are females

2. ADMINISTRATION AND BUDGET

ARIJ has continued to implement its institutional development strategy through creating sustainable, functional and transparent administration and managerial systems. As part of its commitment to effective management; and while believing in the values of transparency and good governance, ARIJ launched an institution development project starting 2006. Through this self-capacity building project ARIJ aims to adapt its managerial performance to international requirements of NGO management standards; enabling the institute to undertake a wider range of sustainable projects in its main thematic areas. Moreover, this project aims at enhancing the institute internal control system which shall as a result contribute to its monitoring and evaluation competence. In keeping with these goals, the actions taken by the institute include the application of sound financial and human resources policies and procedures, in addition to employing a highly developed information system.

2.1 Outputs

1. Producing four manuals that provide a complete collection of the institute policies and procedures categorized as follows:
 - a) Financial Management & Accounting Manual
 - b) Human Resources Manual
 - c) Project Management Manual
 - d) Administration Manual.
2. Enhancing the institute's communication procedures to serve for an efficient implementation of the four manuals; by introducing practical form templates.

3. Developing an electronic data application - which shall be referred to by 'ARIJ e-office'. This application aims for providing a comprehensive information system for the developed procedures, in addition to saving time and reducing paper use.
4. Building the capacity of the administration employees by providing training and introducing advanced applications to improve procedures in the departments of procurement, accounting and human resources.
5. Establishing a solid and effective monitoring and internal audit guidelines.

2.2 Methodology

Sustainable development, with its management, technological and institutional aspects, clearly encompasses human resource development. And since ARIJ already promotes creativity and innovation, the choice was in favour of developing the institute through involving its own personnel instead of hiring external consultants. In addition to building staff capacities this approach allows for applying methodologies that best suit the real development needs of the institute; whereas, most business solution firms, offer previously designed templates that do not necessarily meet ARIJ specific requirements. Furthermore, the cost of hiring such firms was not within the projects' budget.

- Review and study the institute's previous oral and written bylaws.
- Analyze and interpret written regulations and guidelines.
- Perform complex professional and administrative support for the different departments of the institute.
- Research, develop, and recommend a variety of procedures and applications.
- Introduce new policies, and guidelines through consultation and brain storming sessions with the institute's staff members.
- Draft and edit the modified policies and bylaws in a form of specialized and comprehensive manuals with fully integrated procedures that are easy to understand.
- Design efficient templates with professional layout; fine-tuned to eliminate bureaucracy and easy to customize.
- Plan and design a complete information system for the introduced procedures.
- Perform advanced programming tasks to transfer the designed information system into a data software application
- Carry out testing for the integrated data applications.
- Train administration staff on the employment of new policies, forms, and data applications.
- Introduce policies, procedures and data applications use to all ARIJ staff members.
- Present the produced manuals to experts who will provide professional review assessment, and implement suggested recommendations.
- Prepare presentation regarding contents of the manuals for the purpose of board of directors' approval.

The financial manual has been completed, and implemented at the beginning of the year 2007, ARIJ has issued the first manual and has started implementing all polices and procedures that are included in the manual.

2.3 ARIJ Financial Manual

After the completion of ARIJ Financial Management & Accounting Manual in the year 2006, the year 2007 was devoted for the implementation of the manual by the administration staff. So, during this year the manual was submitted to various parties for review and approval including: the board of directors, financial auditors, as well as projects' donors.

To recollect on the previous year, ARIJ financial manual is a technical accounting guide that complements guidance on handling ARIJ financial policies and procedures, in addition to recording financial transactions system. The principles underlying the application of ARIJ accounting standards comply with local and international accounting standards. The manual is kept under constant review. It is updated regularly to reflect developments in international accounting standards and ARIJ bylaws. Any amendments to the manual must be authorized by the board of directors on a yearly basis.

The financial manual is highly welcomed by the hard-pressed finance professional. It is particularly useful to those in small and medium-sized institutions, where institute restructuring, a more complex and urgent institute environment and greater regulation mean that the finance profession must get involved in the whole range of management tasks from functional responsibilities such as procurement, fixed assets management, to employment and NGOs law.

A reliable and practical information resource, the Financial Manual is designed to solve ARIJ financial and general management problems. Its focus is on good institution practices, with a strong emphasis on practical application to the problems of the day rather than theory.

Subscribe to the Financial Manual and ARIJ staff will gain detailed guidance on issues that affect ARIJ success at work. It brings diverse, wide-ranging, reliable advice into one convenient information source that is regularly updated to ensure that ARIJ will always have accurate information.

Through implementing the manual, ARIJ staff members were given the opportunity to learn quickly from the hard-won experience of, capacity building staff, senior accountants, local and external auditors, and donors. And while the financial manual was designed to be a reliable information source with a strong emphasis on practical application rather than theory, the capacity building team provided on-job training for ARIJ administration employees. This training aimed at building confidence in areas as diverse as information technology and strategic planning; offering a wide-ranging advice on how to cope efficiently with general financial management and accounting problems. As a result the implementation of the financial manual enhanced the system by achieving the following:

2.3.1 Manual Definition:

This Financial Manual is the technical accounting guide that complements guidance on handling ARIJ financial policies and procedures, in addition to recording financial transactions system. The principles underlying the application of ARIJ accounting standards comply with local and international accounting standards.

The manual is kept under constant review. It is updated regularly to reflect developments in international accounting standards and ARIJ bylaws. Any amendments to the manual must be authorized by the board of directors on a yearly basis.

2.3.2 Manual Objectives

- Provided guiding principles of approved financial policies such as; authorization limits procurement policy, travel policy, accounts payable system and payroll and benefits policies.
- Provided instructions of how to put approved accounting policies in practice, through describing transactions like; making payments, calculating salaries, recording transactions, filing supporting documents, handling cash, carrying out bank reconciliation, and preparing various financial reports for both managers and donors.
- Updated the accounting system according to the new chart of accounts and bookkeeping entries presented in the financial manual; introducing and applying international accounting standards
- Helped the employees to identify with their responsibilities, by understanding how the roles of financial management, internal audit, procurement, and accounting fit into the entire financial system.
- Operated an effective system of internal control, by making sure that the series of implemented processes and procedures relate to the concepts of control such as; segregation of duties, proper authorization, asset accountability, safeguarding of assets, reliability of financial records, and adequate documentation for all accounting transactions.

1.2.4 Human Resources Manual

ARIJ desires to maintain a competent, stable, and diverse workforce that is well informed in matters affecting employment. The institute also strives to develop and maintain the positive work environment needed to recruit and retain capable, committed, and caring employees. Consequently,

ARIJ realizes that clear personnel policies and procedures are core to the effective management of individuals within any organization. All employers need to communicate their standards and expectations to their employees, in order to minimize conflicts and disputes in the workplace. While many organizations already have personnel policies and procedures, they often fail to formalize them and communicate them effectively to their employees. This results in inconsistencies of application across the organization, which may then leave the organization open to challenge, particularly if individuals feel that they are being treated unfairly. It is, therefore, essential that organizations develop clearly written, workable personnel policies and procedures.

Prior to the institution development project, many HR policies and procedures were included as part of ARIJ general bylaws; other policies remained verbal. Throughout the year of 2007 ARIJ capacity building team, has managed to draft the first ARIJ comprehensive HR manual; modifying previous policies and introducing new procedures and applications. The produced HR manual includes a collection of human resources, guidelines developed to assist ARIJ management and its human resources department with daily human resources management activities; consisting of integrated procedures, policies, and practices; and serving as a reference document for employees regarding their rights, responsibilities and obligations. The policies and practices of ARIJ HR manual are adapted to the legal frame work of the Palestinian labour law, through the contributions and enhancements of ARIJ management and general assembly members.

The manual covered the key issues concerning HR management at ARIJ; covering topics such as: job descriptions; recruitment and selection; employment; payroll processing; attendance; vacations; health and safety; employees' benefits, travel policy; employee development; performance evaluation; code of conduct; disciplinary procedures, and end of service.

As a thorough understanding and working knowledge of the introduced policies and procedures is necessary for the effective management of the HR department, training sessions were arranged by the capacity building team. These sessions presented an overview and explanation of HR manual; introducing a whole new set of applications. As a result these applications encouraged support service and professionalism in the interactions of the HR department with employees; with ARIJ management, and with members of ARIJ stakeholders. The following are some highlights of HR manual policy:

1. ARIJ HR manual is a documentation of ARIJ personnel policies, rules, regulations and procedures for its national Employees. These policies, rules and procedures have been developed to design the framework in which to define, plan, organize, control and develop human resource throughout the Institute. ARIJ manual will provide the personnel with an orientation to their rights, responsibilities and obligations as well as acting as a guide for managers and supervisors in the administration of their staff and staff.
2. ARIJ HR manual is crafted around the policies and procedures of the Palestinian legislation and adapted to the legal structure within which ARIJ staff work, enriched by ARIJ General Assembly experience and knowledge.
3. It is the duty of each employee as well as ARIJ management responsibility to ensure that all procedures within ARIJ manual are understood, respected and followed.
4. The policies and procedures in this manual do not apply to Volunteers and Interns. Conditions of employment are processed individually in the Volunteers and Interns Work Manual.
5. Policies and procedures are subject to modifications and changes for future development in the field of human resource management. All staff members and supervisors will be kept up-to date with all the changes and will be formalized by revisions in the manual
6. These changes are part of the ongoing environmental variations that are simulated in the socio-economic and political situation in the country. However, any modification of the procedures and regulations will be subject to a revision based on the advantages, benefits and responsibilities of the employees and the Institute's administration.

7. Conflict of Interest Policy: an individual shall be considered to have a possible conflict if either:
 - the individual has or appears to have any material; financial or other interest which may impair the individual's judgment in carrying out the responsibilities delegated by ARIJ
 - The individual may gain a personal benefit from the knowledge of information confidential to ARIJ.
8. If an individual believes he or she may have a conflict of interest, the individual shall report such concerns in writing to the HR officer and refrain from further participation until the conflict can be reviewed and resolved.
9. Prohibited Workplace Violence: ARIJ seeks to maintain a safe, healthy and secure work environment. It is ARIJ goal to create a workplace free from violence, threats, harassment, intimidation, and other disruptive behavior on its property. Violence or threatening behavior can include physical acts of violence, gestures, intimidating presence, oral or written statements, and sexual assaults.
10. Employees play a major role in ARIJ efforts by complying with this policy, contributing to a respectful atmosphere, treating all threats seriously, and reporting incidents immediately without the fear of reprisal or criticism. ARIJ treats reports of threatening behavior or violence seriously and will take appropriate action in response such as immediate removal from ARIJ property, suspension, termination and/or referral for criminal prosecution. ARIJ has the right to search any area or property, including personal property, in order to investigate reports of workplace violence.

1.2.4 Communication Procedures

Good communication is one of the basic functions of effective management in any organization. Therefore, and as basic communication tools, ARIJ capacity building team has succeeded to introduce a comprehensive set of processes, templates, forms, checklists charts, tables, in order to facilitate for an efficient implementation of the four manuals. This system was designed to have an effective and speedy communication process; avoiding misunderstandings, confusion or distortions of facts and establishing harmony internally among departments; and externally through communicating with all ARIJ stakeholders.

1.2.5 E-Office Application

One of the biggest challenges for the institution development project was to introduce ARIJ e-office; a new software application that links financial; personnel and project related data. In addition to enhancing the communication system, the e-office application is designed to save procedures time and minimize paper use. The main goal achieved from this software, however; is the development of a project-based payroll system. Besides its core funding the institute operates on project based funding; thus, allocating personnel cost to the undertaken projects on a monthly basis represents a major complexity for its financial management. So, the developed payroll application shall facilitate the process not only by calculating salaries and producing an improved salary slip; but also by distributing salaries; benefits; and end of service costs to various projects. This shall contribute to allocating personnel cost on an actual basis, in addition to documenting these charges for the accounting system.

Through the combined effort of both the capacity building team and ARIJ information technology (IT) unit, ARIJ e-office was designed and programmed throughout the year 2007. During the coming year 2008, the IT team members intend to work on testing and modifying the system. The HR staff, on the other hand, shall be introduced to the system by entering and updating personnel data, in addition to receiving required training on the implementation by the IT staff.

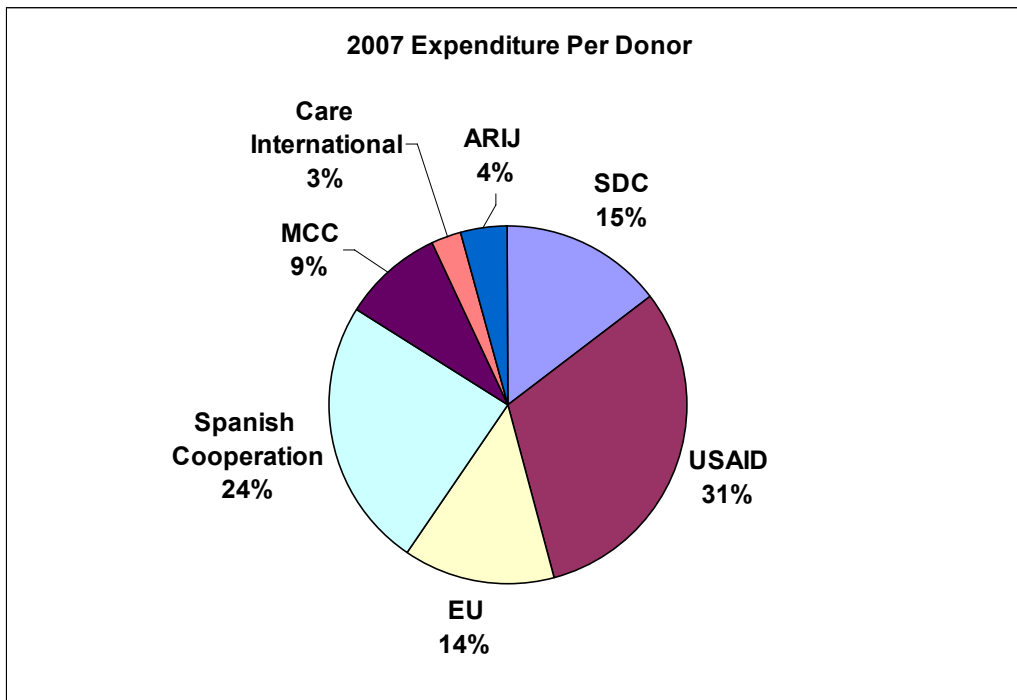
1.2.6 ARIJ Actual Expenditures for the Year 2007

ARIJ enjoys multidisciplinary funding in addition to the Core Funding (SDC 15%) from the Swiss. The following figure and table describes ARIJ actual expenditures for the year 2007 where the main donor is the USDA (ACDI/VOCA 31%) followed by, Spanish Cooperation (24%), EU (14.4%), MCC (9%), Care International (3%), in addition to the generated income from the executed consultancies and services by ARIJ (4%).

Figure (4): ARIJ Actual Expenditure per donor for the Year 2007

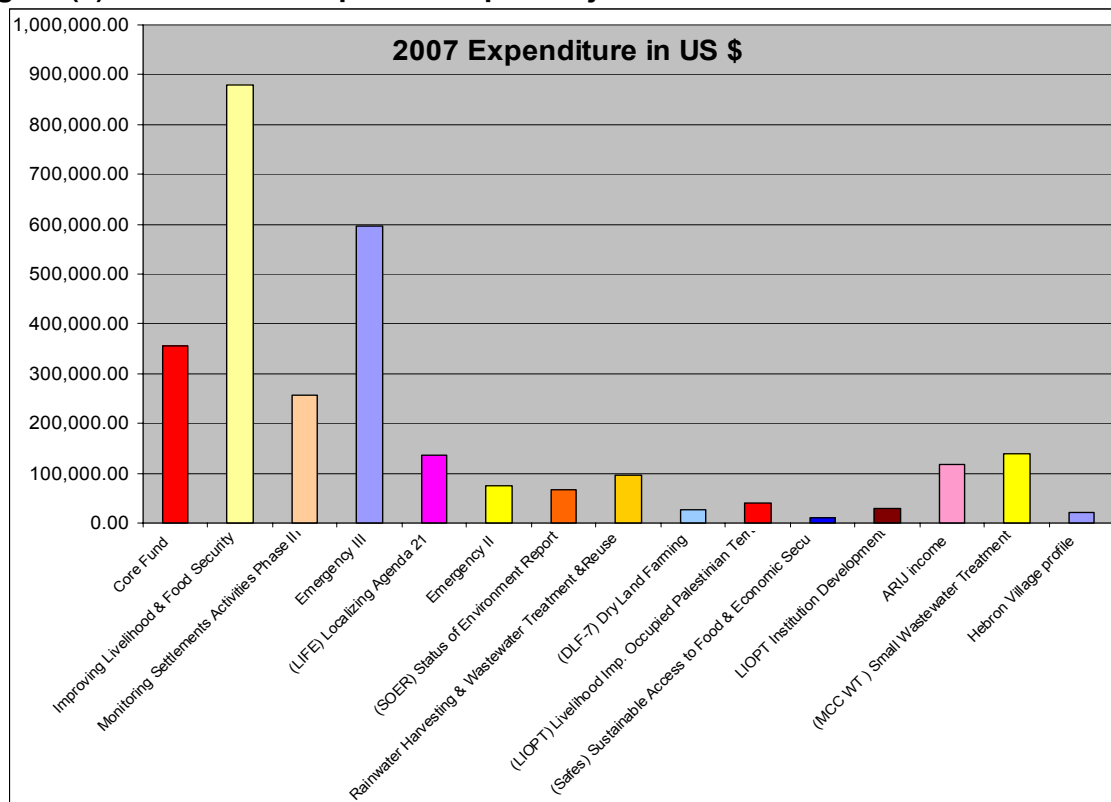

CHAPTER IV: PLANNING AND PROVISION

1. ARIJ Provision 2008/2010

In the last few years, ARIJ has condensed its activities in conducting more development projects in order to achieve its mission by:

1. Improving and developing plant production in the marginalized areas of Palestine.
2. Reducing poverty and improving food security.
3. Resolving complex problems and enable people to sustain the environmental systems that support their communities.
4. Increasing and enhancing water harvesting in order to face greater obstacles coming in the future of the Palestinian community.
5. Supporting and boosting capacity building as well as community involvement at all levels.

In the light of this, ARIJ has witnessed significant advances concerning the overall performance of its activities, as the following indicators show:

1. Increase in number of employees.
2. Increase in the number of visits on the website.
3. Increase in the number of publications such as books, reports, articles, case studies and so on.
4. Enlarge the execution area with the local community.
5. ARIJ serves as a reference for all issues related to Settlement Activities, Water & Environment, Agriculture and Biodiversity.
6. Upgrade and improve the Information Technology and Administration systems.
7. Success in implementing new approaches for small and medium scale water management control.
8. Improve local seed and produce fertilizers more economically.
9. Increase in diversity of technical and financial support for ARIJ activities.
10. Preparing ARIJ workplan for the year 2008.

In spite of all the positive impacts and results mentioned above, there is a conspicuous change that should be taken into consideration for the following reasons:

1. There is a raise of ARIJ budget in a very short period that doesn't exceed two years.
2. There is an increase in the numbers of employees reaching 80 employees for some months.
3. ARIJ has been performing in wider perspective concerning its research and implementation projects.
4. There is a considerable raise in networking, cooperation and partners either locally or internationally, such as CARE international.
5. The uncertainty of the political situation and the possibility for a change in working environment of all the Palestinian NGOs due to political changes.
6. The decline in exchange rate of the U.S Dollar in relevance to the Israeli Shekels as well as the increase in the inflation rate, all of which affect negatively on the performance of the employees and increase the pressure on ARIJ.
7. There is an overlooking for the scientific research and its development due to the increase in the implementation programs.
8. There is an increase in the unemployment rates and the poverty levels
9. There is an increase in demand for the development and implementation activities and emergency programs.

As a matter of fact, in the middle of these interactions, it is of utmost importance to provide innovative ways for facing these challenges, as for ARIJ, it has continued its development and work to reach its aspiration and meeting its goals.

Looking at the future of ARIJ in accordance to the local, national and international situations, it appears that is not an easy thing to proceed. To say the truth, there are lots of hopes that rely on the success of the peace process between the Palestinian and Israelis, but this doesn't reflect the fact of the Palestinian situation, as the upper limit of expected development and improvement in the following years at the Palestinian side, are as following:

- Provide an international plan to support and ensure the work of the current Palestinian Authorities, especially the operation budgets.
- Finance the international organizations in Palestine for the implementation of emergency plans and supportive actions as concluded in the CAP 2008 plan.
- Eliminate of the check-points inside the West Bank to facilitate the movement inside the cities of Palestine.
- Soldier on with separating the West Bank from Gaza Strip, as well as separating Jerusalem from all other areas of Palestine.
- Growth and support for the private sector by implementing a plan for the foundation of two new cities and creation of the peace bridge as well as the cooperative industrial zone in the Jamleh and Tarqumya cities.
- Neglecting the help and support of the Palestinian Non Governmental Organizations (NGOs),
- Increase of support for the international organizations, private sector and governmental organizations in Palestine.
- Increase in the number of the immigrants of the educated and experienced Palestinian individuals.
- Increase the demographic differences among the Palestinians and increase the gap between the poor and rich Palestinians.
- Decrease in the Palestinian Agricultural areas as a result to the Israeli practices and the growth of the urban areas leading to the deterioration of the agricultural sector especially the one depends on small ownerships, but the improvement of the profitable agricultural sector that depends on modern technology, intensive cultivation, and exportation.

Such scenarios would have its implications on ARIJ, which necessitate the provision of strategies that fits accordingly through focusing ARIJ efforts on several aspects as following:

- Intensify the work in the areas of monitoring and assessing the changes in the field of Palestinian natural resources including land, water, vegetation cover and infrastructure.
- Continue monitoring the status of environment in Palestinian Territory.
- Conduct *Environmental Impact Assessment (EIA)* for the suggested developmental projects and study its impacts on the Palestinian environment.
- Continue adopting the sustainable strategy for the survival of the marginalized rural Palestinian farming communities and activate the societal participation in the development.
- Set strategies and mechanisms that should be adopted to keep the sustainable development in Palestine.

Hence to ensure that ARIJ would be capable of running all the mentioned responsibilities, it has to provide appropriate funding to run ARIJ different departments. Such a strategy would not be easy especially concerning the research programs including monitoring the change of the status of natural resources, which is not expected to be of interest to the donors. Hence, ARIJ has to join partnerships, conduct investment projects in its working fields to ensure the sustainability of its programs. ARIJ work plan for the coming two to three years is mentioned in the following two sections.

1.2 ARIJ technical Work plan for the year 2008

ARIJ is willing to continue the implementation of the on-going projects and to further participate in new projects, especially those that will get acceptance during the year 2008. ARIJ is also planning to continue its scientific research in fields of natural resources and sustainable agriculture. ARIJ has other responsibilities that need to get accomplished during the year 2008 such as the following up, updating, and running of local services, capacity building and awareness campaigns, field work, presentations, workshops and meetings, GIS services, and technology. ARIJ is planning to initiate funds for new project proposals.

Part of ARIJ planning mechanism is the development of research at all its fields of expertise. ARIJ has submitted its profile as center of excellence in natural resources management and center of geoinformatics to be identified by the PRC as a national center specialized in these items.

1.2.1 Proposed Activities for the Natural Resource Management Program

1. Continue monitoring the Israeli settlements expansion activities
2. Conduct environmental impact assessment (EIA) for relevant suggested projects.
3. Conduct a pilot project to assess the implications of the segregation wall in four Palestinian communities in cooperation with the HIC.
4. Development of settlements elimination manual.
5. Establish a composting facility in the Hebron District.
6. Establish a national record concerning the implications of segregation wall in cooperation with "حصر الأضرار" committee.
7. Establish an environmental Palestinian village.
8. Establish technology centre for environmental issues.
9. Follow up the Wastewater Treatment Plant project in Nahhalin village and the implementation of relevant projects in other areas in PT.
10. Follow up the production of compost on medium and large scales.
11. Implement wastewater treatment projects on household level and its extension.
12. Follow up the urban growth in the PT areas and institutionalized the available urban data available at ARIJ.
13. Initiate online environmental magazine (half yearly) and environmental calendar
14. Initiate a program about desertification and Human dimension of environmental change in the OPT.
15. Localize and implement Local Agenda 21 in Hebron and other Governorates
16. Forecast Impacts of Climate Change and Variability on Water Supplies and Utilization in the North-Eastern Middle East or (Local Impacts and Threats from Climate Change).
17. Participation in the feasibility study for Al Bahrain qanal.
18. Participation in Galilio European network.
19. Prepare indoor environment of Palestinian schools and its effects on the comfort and performance of children.
20. Prepare the Jordan Valley Information System.
21. Publish the سلسلة الثقافة البيئية
22. Develop an interactive "Atlas of Palestine" and a cars tracking system using GPS and GPRS technologies.
23. Prepare tourist maps for Bethlehem Area in cooperation with Ministry of Tourism and Antiquities.
24. Publish the atlas of 40 years of Occupation.
25. Publish Interactive 1948 atlas.
26. Publish Interactive atlas of Jerusalem.
27. Update the environment information system and formulate committee for the support and sustainability of this project.

1.2.2 Proposed Activities for Sustainable Agriculture Program

1. Continue working on developmental projects to improve the living conditions, livelihood and food security of marginalized rural areas in the PT and to initiate new relevant projects.
2. Continue working with ARDI Palestine, and develop a regional network serving this initiative.
3. Continue working on landraces' seed improvement program and establish unofficial seed system.
4. Introduce the medicinal and aromatic plants cultivation to the rainfed system.
5. Continue providing consultancy services in through field surveys and analytic studies to study the socioeconomic conditions, assess the local communities' needs for development and improvement, and the possibility to improve the agricultural products to go with the modern marketing and exporting requirements and standards.
6. Conduct a comprehensive agricultural survey for the different localities in Hebron governorate and then enlarge it to include the other governorates.
7. Conduct project for the improvement of fish introduction in agricultural ponds in the mountainous areas including the production of fish.
8. Develop the traditional food industry and initiate the first pilot industrial unit.
9. Develop agro-tourism and eco-tourism profitable projects.
10. Develop the traditional and organic Palestinian farm project.
11. Establish a farm for the reproduction of Shami and hybrid goats.
12. Establish a rural market in the southern area of the West Bank to facilitate the marketing of rural products through the different eco-geographical areas and encourage fair trade.
13. Implement capacity building program on both the individual and institutional levels.
14. Reactivate the Hydroponics units for the forages production.

1.2.3 Proposed Activities for Information and Technology Program

1. Convert all ARIJ web mapping solutions to open source Mapguide.
2. Complete the development of ARIJ E-Office application including testing, launching and training ARIJ staff on the use of the system.
3. Develop a web based application for the Palestinian Environmental Information System (PEIS), in which the IT staff will be using open source geo-spatial solutions to accomplish the task. The decision of converting the system from a desktop application to a web application was made to offer the public the ability to use the system.
4. Develop and improve more effective and practical archive system.
5. Integrate E-Token security system into the driving test application that was developed by the IT program. The E-Token solution will be used to restrict the use of the system to student who has E-token installed on their computers. Since the system only supports Arabic and German languages a decision was made by the German company to develop the system to integrate more languages.
6. Participate in the 2nd METIS Training & Seminar in Cairo. METIS is the MEdiTerranean Introduction of GNSS Services, and as ARIJ is partner in METIS, it will be implementing the following activities in the year 2008:
 - a. Development of a "GNSS Regional Plan" with the 5 to 10 years scenario
 - b. Running a programme of training & awareness.
 - c. Performing service demonstrations involving local Palestinian actors. The Objective of MEDaCoN (Mediterranean Data Collection Network) demonstration is to make a continuous and real-time knowledge of the real status of the EGNOS extension system in the Mediterranean region.
7. Produce interactive atlas for Palestine.
8. Produce interactive atlas for Jerusalem.
9. Produce video tapes for ARIJ and its activities and programs.
10. Restructure ARIJ website and integrate more languages into the site.
11. Seek to get an ISO 2002 (ISO 9002) certificate.

1.2.4 ARIJ Potential Projects

Several project proposals were prepared during the year 2007. Some of these projects were developed and submitted and others still in the development process, whether by ARIJ staff only or jointly with other local and/or foreign organizations. Following is the potential proposals:

- A Proposed Compost Production Facility to Serve Eight Localities in the Hebron District.
- Assessing environmental and natural resources' sustainability in a future Palestinian State - Millennium Institute and United Nations' Agenda 21.
- Assessing environmental and natural resources' sustainability in a future Palestinian State - Millennium Institute and United Nations' Agenda 21.
- Developing a support system for assessing sustainability of a future Palestinian State - Millennium Institute and the European Union.
- Emergency Jobs Program (EJB)" in the Occupied Palestinian Territory (OPT). Related to waste management (water and sanitation systems), land reclamation and rehabilitation, agriculture infrastructure, and capacity building to sustain natural resources and income generations - ACDI/VOCA, USAID, USA.
- Enhancing Food Security in Marginalized Rural Areas of Bethlehem and Hebron governorate (phase 4) - Spanish Cooperation.
- Establishing a GIS based information system of the targeted village (Jalame).
- Establishing a Palestinian Centre for Environmental Technology and Education (CETE).
- EU Partnership for Peace 2008.
- Gender Mainstreaming and Integrated Water Resources in the Occupied Palestinian Territories - Gender-Water Alliance (GWA).
- GLOWA Jordan River Project, Phase III. Related to strategies for coping with climate change and water scarcity in the Jordan-River region, with the focus on agriculture, irrigation, water-resources' management and waste management -GLOWA Jordan River.
- Improving livelihood and agricultural activities of poor rural families in the southern part of the West Bank- CAP 2008.
- Improve food security of poor households in marginalized areas-MCC.
- Improving Rural Marketing System in Palestine (RMS) – SDC.

- Land Registration of Damages due to the construction of the Segregation Wall in the West Bank area – Habitat International Coalition.
- Livelihoods, Income and Food Security Improvement in the Bethlehem and Hebron Governorates (LIFS) - PAZ Y COOPERACION/ Spain.
- Master planning the site area of the proposed Palestinian Center for Environmental Technology and Education- Osh Gorab, Beit Sahour.
- Red Sea to Dead Sea feasibility study.
- Potential Renewable Energy Resources in the Occupied Palestinian Territories.
- Potential renewable energy resources in the Occupied Palestinian Territories - "Energy Globe", Austria.
- Registration of damage incurred due to the construction of segregation wall in the occupied Palestinian Territory.
- Set up National Wastewater Reuse Regulations and Legislation/ Gaza Emergency Water Project II-Institutional Reform and Capacity Building Component for PWA.
- The Creation of a Traditional Shepherds' Farm in Beit Sahour City.
- The creation of a regionally traditional Canaanite Farm/horticultural centre in order to create local employment as well as to serve as a touristic, cultural, and educational center for the

local community and tourists/visitors.

- The Palestinian Environmental Village Profile: Mapping the Social and Physical Infrastructure of five localities in Ramallah and Al- Bireh Governorate.

1.3 ARIJ INSTITUTIONAL PLAN FOR THE YEAR 2008

As already identified in the project's objectives, two more manuals need to be completed by the capacity building team in addition to other development plans. Thus, during the year 2008 the capacity building team intends to carry on with its institutional development by introducing the following:

1.3.1 Project Management Manual

While ARIJ is developing its sustainable programs by implementing a variety of projects, the need for grants management manual is becoming more essential. This grants manual shall function as a guide for all staff involved in any project related tasks covering the key elements of the project cycle, including project identification; design; implementation and evaluation. The manual shall contain, however, more emphasis on the implementation, as it is expected that most of the project participants have a good understanding of the project cycle. In addition, the manual is to introduce a solid project monitoring and evaluation procedures, which shall be applied practically through the employment of the e-office application.

1.3.2 Administrative Procedures Manuals

As the three previous manuals provide solid guidelines for all ARIJ financial and managerial transactions, this forth manual shall complete these procedures by offering information about the institute general administration policies. Thus, this manual is to clarify some administration topics like: the role of the board of directors; the chain of public relations; and the role of the staff committee. In addition the administration manual is designed to function as an office guide giving instructions on ARIJ day to day administration tasks including: vehicles system; office equipment; maintenance and cleaning. Finally, the manual shall introduce the chain of communication to new employees, and illustrate the use of communication tools like software applications and correspondence forms.

1.3.3 Institution Development and Risk Management Assessment

During the year 2005 and prior to the institution development project, ARIJ had hired an external firm to assess its organizational risk; the following major risks were identified as a result of the assessment:

1. *Political risks: Closures by Israelis impose significant risks that limit ARIJ staff ability to communicate with programs target groups and consequently the accomplishment of its projects.*
2. *Operational risks: ARIJ is exposed to the risk that its activities might not achieve its objective due to internal and external factors.*
3. *Financial risk: ARIJ is exposed to the risk resulting from its inability to secure the funds necessary to perform its activities.*
4. *Compliance risk: ARIJ is exposed to the risk resulting from non-compliance with donors as well as other regulatory agencies requirements.*
5. *Information technology risk: ARIJ is exposed to the risk resulting from using information technology as ARIJ is heavily relying on information technology in performing its activities.*
6. *Internal control risk: ARIJ is exposed to the risk internal control systems failure to prevent, detect and correct errors on a timely basis.*

As a direct achievement of the institution development project, it is reasonable to conclude that the integrated procedures have contributed to the minimization of the last three risks (4-6) to a great extent. Concerning the other risks, which are generated by both internal and external factors, ARIJ intends to carry on with its planning, organizing and controlling the institute's resources to eliminate negative outcomes. Throughout the coming year and as part of this process, ARIJ is planning to conduct a risk management workshop; involving representatives of all its stakeholders. The workshop is hoped to cover the main risk assessment issues generating results such as:

1. Identifying major risks that are still affecting ARIJ operations.

2. Recognizing potential liabilities that might negatively impact the institute's programs.
3. Establishing a risk monitoring strategy, to mitigate risks proactively.
4. Suggesting some risk controls; especially in relation to the security of future financial opportunities for the institute.

In addition to the workshop, and as part of a systemic process to manage risk, ARIJ is planning to hire an external consultancy firm in order to provide expert's solutions concerning organizational risk. The main outcomes that are to be expected from a specialized assessment include the following:

1. Conducting an evaluation of the implemented financial and administrative procedures; as resulted from the institution development project.
2. Identifying additional operational risks, and assess their real effect on ARIJ programs' sustainability.
3. Evaluation of ARIJ risk management approaches, and determine the adequacy of risk controls.
4. Suggesting administrative and programming improvements to existing controls.
5. Introducing practical solutions to major risks facing the institute.
6. Conducting a sample review of the institute programs' activities.
7. Assessing the impact of ARIJ programs on different stakeholders including beneficiaries.

1.4 ESTIMATED BUDGET FOR THE YEAR 2008

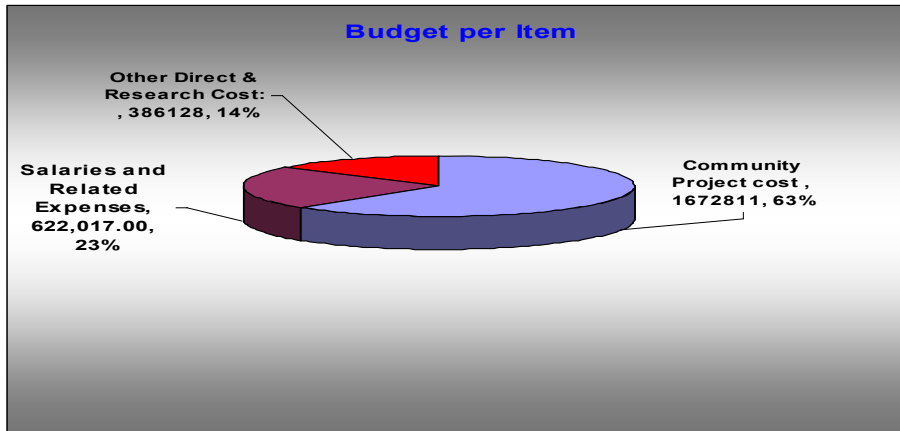


Figure 6: Estimated Budget per Donor for the Year 2008

ARIJ budget is mainly distributed between research and administration costs and community development costs. The allocated budget for community development formed 63% of ARIJ expenses in the year 2008 (see Table 2). This amount of money was transferred directly to the beneficiaries as cash or materials. This growth in the cost of community activities is consistent with the increase in the number of funded food security, small scale waste water treatments and other implementation projects. The trust of donors in ARIJ performance in addition to ARIJ financial and administration systems encouraged them to fund more of the submitted projects (see Figures (5 and 6)).

Figure 5: Distribution of Budgets per Item 2008

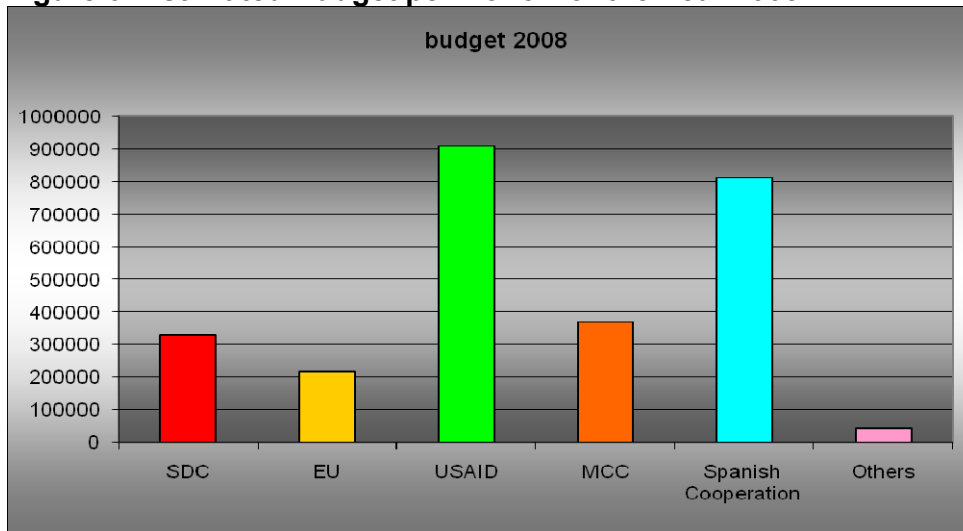


Figure 7: Estimated Budget per Project for the Year 2008

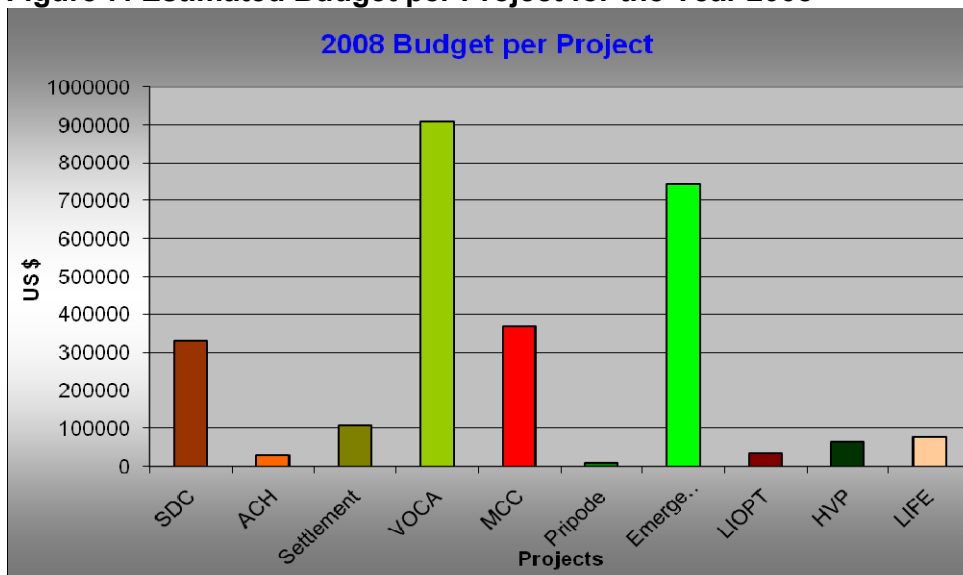
